PRIVILEGE OF THE FLOOR – Chairman S. Killourhy opens privilege of the floor at 7:12PM. M. Nihan inquires about the status of the Cell Tower at Town Hall. S. Killourhy states no application has come before the Planning Board to date. Councilman A. Coiro states the town Board is still working with Verizon to find a location for the tower. J. SOLAR PROJECT: Discussion – Herb Ortiz and Gordon Cochrane of Energy In The Bank.

Councilman Coiro states that he has put in many hours on this project and is prepared to make his recommendation to the Town.

H. Ortiz states that he is a developer and the Landfill site is very attractive to his company. Discussion regarding a 2 megawatt project, \$20,000 per year to the town for the next 20 years with a 1% escalator. He adds that his investors would be receiving a tax benefit. He speaks of a 9 cent rate with a 1.5% escalator because of Councilman Coiro's countless hours and persistence. He presents the board with an MOU and a lease agreement.

Supervisor Legg asks if the town's energy costs would be covered.

H. Ortiz states that there is some room to work something out, adding that the project would be one 200 KW solar field for the town plus two others.

Discussion regarding what happens at the end of the twenty years, whether the town has to buy it at fair market value or whether it gets turned over to the town through NYSERDA.

Discussion regarding a 20 year PILOT program for the piece of land at the landfill and whether or not this would occur at a county level.
