BOARD DISCUSSION: Rescheduling of the November meeting date. The November meeting has been scheduled for Tuesday Nov. 14, 2017 at 7:00PM.

PUBLIC HEARINGS: Haines Falls Auto Site Plan-remains open. No comments from the public. A letter from J. Michaud-Uhrik has been received and the Board will review when the item is discussed on the agenda. Hearing not closed.

OLD BUSINESS:

1) Haines Falls Auto Site Plan & NYS DEC C&D Processing application: Haines Falls – Rory France Public hearing remains open. J.Michaud – Uhrik is recused. MOTION: by R. Haines to keep the HFA Site plan public hearing open. Seconded by S. Killourhy. Motion carried. The Board acknowledges the requested documents were received from applicant R. France and Engineer D. Rider P. E. on Sept. 26th, 2017. The Board passes a MOTION that the materials requested by the Planning Board at the September meeting were submitted on time and satisfactory. A memo was given to the Town Board for their special meeting on October 4, 2017. The SEQR review continues on this SEQR Type I action. The Board will review all documents submitted and review the Full EAF for the next meeting on November 14th.

The Board acknowledges the comment letter from R. Weitz PE of Barton & Loguidice 9/2/17. The Board acknowledges the comment letter from R. France dated 10/3/17 responding to the B & L letter of 10/2/17.

The Board discusses and reviews the submit, discussion with J. Michaud –Uhrik in her request for protected view shed of the vehicles parked on the "showcase" and from people trespassing on her property when looking at the "for sale" vehicles. Applicant and J. M-Uhrik will discuss further, and come back to the board with resolve. Applicant has agreed to a Visual analysis for the height of the proposed C & D building a balloon test will be conducted and notice will be given when the test will be.

2) Villa Maria Site Plan; Sketch Plan: Haines Falls – Darrin Elsom P.E., Sarah Killough-Dhar

Project description: Building renovations of existing structures, wastewater treatment system installation, evaluation of water supply (existing wells), pool area renovations, closing 23A entrances, construction of new parking areas, walking paths and stormwater plans.

3) Twilight Park Wastewater Collection & Disposal Site plan; Sketch Plan: Haines Falls – Alan Tavanner of Delaware Engineering presents. The Board acknowledges received application, narrative, full EAF, and sketch plan with renderings. Project description: Upgrades to the Twilight Park sanitary sewer system. A gravity sewer installed along Ledge end Road running the length of the community. A onsite treatment system and septic system along 23A and Sunset Road. There will be a small maintenance building constructed as well as a road into the treatment site off Sunset Road. The Planning Board is seeking Lead Agency status in the coordinated review for this SEQR TYPE I action. The Planning Board has sent the application to Greene County Planning for 239 review of the application.

<u>4)Hunter Mtn Ski Trail Expansion Site Plan Review; Sketch Plan</u>: Hunter – Mary Beth Bianconi of Delaware Engineering presenting with Russ Colton of Hunter Mtn Inc. The Board acknowledges receiving the application, Full EAF, and sketch plans.

Project description: Addition of intermediate ski terrain (5 trails) and a new lift with parking areas and access road. The proposed work will disturb approximately 48 acres of land owned and operated by Peak Resorts, Inc. The project is located west of the existing Hunter Mountain Ski trails. Access will be from Route 23A and Deming Road. No water or sewer service will be required for the proposed project.
