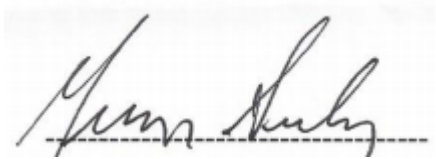
**Hours for Security will be 12:00 pm to 8:00pm Saturday and Sundays as well as Holidays.**
