# SUPPORTING PARTICIPATION IN THE NEW YORK CITY DEPARTMENT OF ENVIRONMENTAL PROTECTION FLOOD BUYOUT PROGRAM

78 Goodrich Lane, Hunter, NY 12442

**WHEREAS**, the Town of Hunter is subject to flooding that can damage property, close roads, disrupt traffic, and present a public health and safety hazard; and

WHEREAS, at the request of local communities, funding support from the NYC Department of Environmental Protection (NYCDEP) is being made available to help property owners who meet eligibility criteria in two flood buyout program categories – 1) recommended within a Local Flood Analysis (LFA) and 2) outside a LFA that meets criteria for one of three sub-categories – Erosion Hazard, priority stream restoration project, and inundation hazards, and

**WHEREAS**, the Town has been approached by the homeowner at 78 Goodrich Lane, Hunter, NY in the Town of Hunter, tax parcel # 164.00-3-14.1, requesting consideration for a voluntary flood buyout given the hazardous nature of the home on an eroding stream bank, and

WHEREAS, site visits from the Greene County Soil & Water Conservation District, the Catskill Watershed Corporation and NYSDEC have occurred over a number of years and have documented the steady advancement of the eroding hillside, most notably within the last few months, warranting an imminent threat to the home, and

**WHEREAS**, the risk level in the last two months increased from moderate to severe with significant documented property loss putting the home in greater jeopardy as the eroding streambank steadily worsens; and

**WHEREAS,** the Town of Hunter in using the guidance from the technical agencies to establish the severity of the erosion hazard approves the property owner to enter the NYCFBO and defers to the NYCDEP to own the property should it go forward.

### NOW, THEREFORE BE IT RESOLVED THAT:

The Town of Hunter supports working with the NYCDEP, GCSWCD and the homeowners of 78 Goodrich Lane, Hunter, Christine and Brian Nolan/Nolavic LLC, to apply for assistance in the NYCDEP-sponsored Flood Buyout Program to permanently remove this flood hazard.
