COVID POLICY

Discussion – exposure cases not currently having to quarantine, positive cases only and County ordered quarantine. Town Board asks the Town Clerk to contact Greene County Public Health to find out their current quarantine regulations re: 10 days versus 5 days. Discussion on need for at home test kits, compensation for testing and cost of testing. L. Gardner states that Greene County does not yet have test kits, but the Towns will be informed as soon as they do.

Sgt. Haines to forward information to the Supervisor’s office re: 14 days pay up to three occurrences.

Supervisor Mahoney makes a MOTION that the Town of Hunter shall follow Covid guidelines as determined by Greene County Public Health and that when we have a

positive employee that they will be compensated with American Rescue Plan Funds in line with NYS labor laws. Proof of positive test required, id and documentation from Greene County Public Health of quarantine orders, also a negative test result must be provided if employee is returning to work as part of their directive prior to quarantine ending.
