Supervisor Mahoney calls the meeting to order at 6:00 PM with the Pledge of Allegiance to the Flag.

## **AUDIT**

### PRIVILEGE OF THE FLOOR

Susan Haines asks about the status of the unsafe structure next to her residence in Lanesville.

Supervisor Mahoney states the Town Board is moving forward with a notice of an unsafe structure and when the time frame is over, if no response from the property owner, the building will be condemned, and costs will be added to their tax bill.

- S. Pellizzari reminds the board that the public hearing is still open.
- M. Nihan asks if Zoning and the Comprehensive Plan are still on the agenda.

Supervisor Mahoney states this is all still on the table as well as short term rentals, employee handbook and a reval. The board is still catching up from Covid.

Joe (unknown last name) states he takes care of three parcels up by the old dump and for the last four years he has been chasing people trespassing on the property, mainly hunters who he feels are gaining access to the property from the Town landfill property. He is asking the Town Board for assistance with keeping people off the posted property.

Discussion on new gun laws, the possibility of limiting the number of hunters on town property with a permit system and the location of the town's gate.

Sgt. Haines states there are laws and avenues in place to have people arrested and advises those present to call Encon if they have hunters trespassing on their property or find cameras on their property.

# PILOT/RUPCO PROJECT

Discussion

Supervisor Mahoney states the Town of Hunter is the Pilot entity as the town is the assessing unit. He states the proposed documents have been reviewed by the Town Attorney and he has recommended that an outside attorney review the document and negotiate on behalf of the Town.

Councilman Semenza makes a MOTION that once the town receives more information from the Town Attorney that at a future meeting the board will make a motion to engage with the outside attorney suggested by the Town Attorney. Seconded by Councilman Reale.

#### **SIGN PERMIT APPLICATION**

## **SEPTIC FAILURE**

Board discussion with Code Enforcement about a septic failure at 70 Osborne Road. S. Pellizzari states she has spoken with the homeowner who refuses to address the issue adding that the Town Attorney has recommended that the home be condemned. She states that there are other issues as well with a portable propane tank, roof issues and the neighbors having their water tested.

Discussion: Daily penalties to the homeowner, court fines, removal of the Certificate of Occupancy.

Supervisor Mahoney states that a Do Not Occupy does not make the homeowner fix the problem. S. Pellizzari has sent an unsafe structure violation letter to the Town Board as per the Town Attorney and the Town's Health Officer is involved.

Supervisor Mahoney to discuss the issues with the Town Attorney.
