Supervisor Mahoney calls the meeting to order at 6:01 PM with the Pledge of Allegiance.

AUDIT – The following vouchers were audited and approved for payment. What stood out most about Mike was his sharp wit and his remarkable sense of humor. No matter the situation, he could lift spirits with just a few words or a well-timed joke. He brought a sense

of ease and camaraderie wherever he went, and his presence always made our team feel stronger and more connected.

To the Overbaugh family – thank you. Thank you for sharing Mike with us for all these years. We know the weight of his loss is heavy, but we hope it brings some comfort to know how deeply he was loved and respected by all of us here.

It is with great appreciation and heartfelt gratitude that we present this plaque in honor of Officer Michael Overbaugh. May Mike's memory continue to inspire us all.

#### **ELECTRONIC BANKING POLICY**

L. Hamrah-Poladian would like to add more safeguards to the draft policy. She is opposed to information being accessed anywhere other than within the Town Hall building.

Supervisor Mahoney states the court would have read only access which could be accessed elsewhere. He asks L. Hamrah-Poladian to bring her edits to the next meeting.

#### **HUNTER TRAIL COMMITTEE**

Acknowledged notice of meeting set 4/8/25.

Discussion on fundraising.

Supervisor Mahoney moves to the audience side of the table acting as the owner of NexStep Digital. He states the Town would collect funds and put into a Hunter Branch Rail Trail account, adding the Town's website needs updating/upgrading because it is not currently set up for commerce. He states that the approximate cost to make these upgrades is between \$1500-\$2000.

Councilman Reale makes a MOTION to authorize the Town Board to appropriate up to \$2,000.00 to hire NexStep Digital to modify the Townofhunter.gov website to be able to accept donations going specifically to a singular bank account to hold those said dollars for Hunter Branch Rail Trail's trail efforts.

#### NO SECOND

Councilman Reale modifies the above MOTION to add the Town's website design will allow contributions to donate for general trail development and/or specific for the Hunter Branch Rail Trail handicap accessibility and development. Seconded by Councilman Kukle.

Councilman Reale makes a MOTION to modify the motion to authorize the Town Board to appropriate funds for NexStep Digital from the General Fund Savings. Seconded by Councilman Kukle.

Discussion on the need for a merchant account, Stripe payment processing system and a bank account which the board feels is all covered under the motions above.

S. Mahoney moves back to the Supervisor seat with the Town Board.

Supervisor Mahoney states it is now mandatory for all municipal websites to have a .gov domain, which the won has implemented. He adds there is an issue with the emails as they are under the old domain name of gov.com, this will need to change to comply. M. Czermerys will be working on this.
